

# Memorandum of Understanding (MoU)

Between

Govt. Vijay Bhushan Singh Deo Girls College, Jashpur Nagar, Dist.-Jashpur (C.G.)

and

K R Technical College, Ambikapur, Dist.-Surguja (C.G.)


## 1. Purpose and Scope


The purpose of this MoU is to increase Academic and Research collaboration between Two Departments (Department of Computer Science and Department of Botany) of Govt. Vijay Bhushan Singh Deo Girls College, Jashpur Nagar, Jashpur and Two Departments (Department of Computer Science and Department of Botany) of K R Technical College, Ambikapur, Surguja so that Teaching-Learning-Research process become more effective and student will get benefit of experiences and knowledge of Faculty Members of both Institutions. As a result a better Teaching-Learning-Research environment will be created between above mentioned Departments of Two Institutions.

The purpose of this MoU is for Academic and Research purposes.

2. Responsibilities of Department of Computer Science and Department of Botany of both Institutions (Govt. Vijay Bhushan Singh Deo Girls College, Jashpur Nagar, Jashpur and K R Technical College, Ambikapur, Surguja) :-

- Above mentioned 02 Departments of both Institutions will become Peer Departments for this MoU.
  - Faculty Members will deliver at least 01 Online Lecture per month from each side (Minimum 24 Online Lectures per Academic Session 12 from one side and 12 from peer side) on Emerging/Research Areas or based on Syllabus of Affiliating University.
  - Google Meet, Skype, YouTube, WhatsApp, Telegram or any other online application may be used as interest of students and faculty.
  - Students Visit to the Partner Institution (if required) can be arranged on their own expenses.
  - Lecture Details, Attendance etc. will be documented from both sides for future reference.
3. Both Institutions will collectively provide a Certificate of Appreciation/Work at the end of each month to the Faculty Members in Hard Copy and E-Certificates of Participation to the Students.
4. Remuneration/T.A./D.A. will not be paid for any work to anyone.
5. This MoU shall be valid from the upcoming Academic Session 2022-2023 (Effective Date: July 1st, 2022) and shall remain in force for 05 (Five) Academic Sessions from the Effective date, unless terminated earlier by either Institution.
